Hello and thank you for visiting the Tel Aviv Medical Clinic website. (TAMC)- (the "Site"). Please take the time to read the terms of use, as actual use of the site indicates acceptance of the terms set forth below.

Reference to the terms of use is valid for both men and women, and the use of the male body is for simplicity of description only.

What is the purpose of the Tel Aviv Medical Clinic website?

1. The website provides you with comprehensive details about the various services offered at the medical center in Tel Aviv. As one of the center's focuses on serving the public, you can book appointments directly through the online appointment site (named: "appointment booking site") or pay for a private service proactively on the site.
2. The appointment booking website project is an initiative, the purpose of which is to enable the patient population in Israel and outside Israel to make reservations for the medical services at the hospital in an independent and digital way. The TAMC Medical Center reserves the right to update the list of services and clinics for which an appointment can be booked through the website.

Who is the site for?

1. The TAMC Medical Center invites anyone who wishes to view the site to browse it and enjoy the available offerings.

2. The appointment scheduling website is intended for all customers who wish to schedule an appointment at the TAMC Medical Center. At this stage, the appointment scheduling website does not address the issue of payment for the appointment and you must arrange payment for the service through your health insurance fund and/or your insurance arrangements and/or independent payment.

For which consumer is the site intended?

1. The TAMC Medical Center opens its doors to all visitors, offering the information and services presented therein.

The website for booking appointments is designed to serve all surfers who consider it appropriate to coordinate a visit to the TAMC Medical Center. as part of the service. In order to arrange the payment of the service, you will have to contact the health fund you belong to or make a payment directly through the website.

When the information displayed on the website is original from a third party, TAMC Medical Center is not responsible for its accuracy. You release TAMC Medical Center from any liability regarding the reliance or use of information on the website that does not originate from the center itself.

2. 2. If your personal information is updated, you must alert the medical center or if you discover errors in the personal information displayed on the website.
3. The contents and information on the website are provided for informational purposes only and are not a substitute for professional medical or legal advice. You are required to consult with qualified authorities before any medical decision or operation. The user is solely responsible for using the site or relying on its content.

What source of information are you referring to on the website through the links?

1. Responsibility for the information on the linked sites: When someone arrives at the TAMC Medical Center website and transfers himself to another site through a link, the information and content on the external site are the responsibility of the external site and not the medical center. Processes on the linked websites: for the registration to external websites, the user may be asked to provide personal details. The medical center clarifies that it is not responsible for those processes or the information that the user provided.
2. The correctness of the links: the medical center does not guarantee the correctness of the links, that is, a link may not work or may not lead to the relevant website.
3. Changing and removing links: The medical center reserves the right to change, remove or add links to other websites at its sole discretion.

In conclusion, the medical center clarifies that it is not responsible for the content or details provided on the external websites linked from its website, and that it can change the links appearing on the website at any time.

Obligations of the user on the Tel Aviv Medical Center website:

1. Agreement to the terms of use: By viewing and using the website, you agree to the terms of use as detailed in the document.
2. Awareness of the personal information: The personal information received will be disclosed on the various platforms of the online services.
3. Awareness of the law on legal qualifications and guardianship: every parent must be aware of his rights and duties as a legal guardian of his children.
4. Responsibility for bringing an order denying guardianship: In the event of receiving a judicial order denying guardianship, the user must bring the information to the center's attention.
5. Consent to the privacy protection policy: The user agrees to the center's privacy protection policy.
6. Secure access: The various platforms of the online services require identification using an ID card, date of birth or a personal password.
7. Notification of information security on the network: The user is aware of the network's limitations on information security.
8. The user's responsibility: the user undertakes to use the website appropriately and ethically and to prevent damage to the center or a third party.
9. Prevention of damage to the website: the user undertakes not to damage the website or the computer systems linked to it.
10. 4. Making contact if necessary.
5. Maintaining the website and monitoring your use of it.

Information security

The medical center undertakes to take all possible measures to protect the information you provide. However, we cannot guarantee absolute protection of our information systems against hacking or illegal use by external parties. Therefore, the medical center will not be responsible, directly or indirectly, in case of disclosure or illegal use of the information you provide, as a result of hacking or acts that are not under our control.

Cost of using the site?

TAMC Medical Center will do its best to protect the information you provide, but cannot guarantee complete security against illegal intrusions and uses. If information you provided is disclosed due to hacking or any other reason beyond our control, the center will not be responsible. Therefore:

- You agree that you are responsible for maintaining your password and email, and access to your computer and phone. You release the Center from any liability in the event that your password is disclosed.
- You are obligated to protect your password and prevent its unauthorized use.
- You understand the dangers of disclosing your password - both intentionally and through loss or theft - and the risk of exposing sensitive medical information.
- In case the password is revealed or suspected, you are obliged to change your password on the website.
- After you use the service, it is your responsibility to delete all sensitive information that may be accessible to others. You release the center from responsibility for that information.
- You understand that while using the website the information may be disclosed to others in your environment, including family members. You are obligated to maintain the privacy of the information.
- You agree to log out of the website after you finish using it to avoid disclosure of information.
